



LeadAbroad Code of Conduct Summer 2021

As we plan for summer 2021 programs to serve the LeadAbroad purpose, **to transform the trajectory of individuals' lives, impact communities and create a better world**, we ask all students and staff to be fully aware of our shared responsibilities in the current environment. In order to operate safe and transformative experiences, all 2021 students and staff must agree to the following code of conduct. The interconnectedness of our world is more relevant now than ever and we all must do our part to create safe study abroad experiences.

These guidelines are based on the current expectations and will be updated to reflect the fluidity of the situation. We expect students and staff to abide by any updates that LeadAbroad communicates to 2021 students or staff.

This code of conduct falls under the LeadAbroad program rules which all students and staff agree to in the program waiver. **Failure to abide by this code of conduct will result in disciplinary action up to dismissal from the program at the student's expense.**

We all have a shared responsibility in order to protect one another and minimize the risk of coronavirus spread in our countries. Please review the following code of conduct carefully.

Before I travel, I will:

- Attend or watch all required pre-departure orientations or training sessions
- Complete my health form
- Complete all requirements as outlined by my home university
- Quarantine for ten (10) days leading up to the trip or quarantine for the requisite time recommended by the CDC at the time of departure
- Take a COVID test within 72 hours of departure and bring documentation of negative results. The type of test may be dictated by airlines and/or governments.
- Receive a **FLU** vaccine if available to avoid potential misdiagnosis and quarantine. LeadAbroad will not unilaterally require the COVID-19 vaccination for summer 2021; however, we will defer to governments, if required. We encourage students with access to receive the COVID-19 vaccine.
- Bring a cell phone with the ability to receive international data via international data plan or local SIM card
- Pack essential supplies including CDC-approved face coverings, thermometer, alcohol based sanitizer and cleaning wipes
- Delay my arrival if I show any signs of sickness or has been in direct contact with a known COVID-19 positive individual and has not yet received a negative COVID-19 test result

While abroad, I will:

- Attend all required training sessions
- Complete my daily health assessment including symptoms and temperature checks
- Follow all local government laws and guidelines, including but not limited to those regarding face masks, social distancing, curfews and capacity limitations. Consequences for breaking local laws include fines and/or imprisonment.
- Wear masks or face coverings, if required. **Based on current requirements in our program locations, face masks are required at all times when you leave your private residence.**
- Maintain social distancing whenever possible (excluding my personal accommodations)

- Follow all accomodation guidelines regarding guests and capacity limitations. Students should not gather in each other's accommodations and are encouraged to gather in outdoor spaces
- Isolate or quarantine as required by LeadAbroad and/or local government guidelines if you exhibit symptoms associated with COVID-19, tests positive or has been in close contact with someone who has tested positive
- Comply with all inquiries for purposes of contact tracing
- Take responsibility for my independent travel and extracurricular activities. I understand that traveling independently to a COVID-19 hotspot may result in quarantine after I return, additional testing or other consequences. LeadAbroad will continue to monitor and communicate restrictions for independent travel and extracurricular activities and it may be necessary to restrict movement or activities more than local government guidelines in order to protect the LeadAbroad community abroad. Students should wait for guidance from LeadAbroad prior to booking independent travel.
- Understand that as a visitor, I am subject to all local laws and restrictions and that LeadAbroad is not able to intervene on my behalf
- Comply with entry requirements to return to the US as outlined by the CDC or airlines
